# **Membership Application**

- Step 1. Please provide a <u>completed application form</u> and <u>colour copies of Electrical Licenses</u>,

  <u>Certificates</u>, <u>and Authorisations</u>, <u>etc</u>., to validate your membership grade eligibility to the IEI

  Membership Director at the addresses listed above.
  - Applications received that include all of the above and are accepted move to step 2,
  - Incomplete applications will be returned requesting further information.
- Step 2. IEI administration will send your membership fees invoice inclusive of Application fee and Membership fee to your email address.
- Step 3. Upon clearance of membership invoice payment you will receive the following documents:
  - IEI Membership card via Australia Post.
  - Receipt for membership fees payment via email.
  - IEI welcome letter via email.
  - IEI Code of Conduct via email.
  - Details for access to the IEI website member's area (via email from IEI webman).
  - you will be added to the email alert list at this time.

## MEMBERSHIP GRADES - QUALIFICATIONS REQUIREMENTS.

## Corporate Membership eligibility.

- 1. Persons who have been authorised by legislation or by a supply authority or inspecting organisation to inspect electrical installations and or equipment for compliance with the minimum standards required by legislation.
- 2. Persons who supervise or control the technical duties of those persons defined in clause 1 above.
- 3. Persons who hold an Electrical Engineering Degree, Diploma, Associate Diploma / Degree, or Advanced Diploma / Certificate (*i.e.*, *qualification grade minimum AQF6 or greater*) as recognised by the Board of Directors or equivalent qualifications.

#### Associate Membership eligibility.

- 1. Persons acceptable to the Board who hold an electrical workers licence which allows them to legally carry out electrical installing work in a State or Territory of Australia or other Country without supervision.
- 2. Persons who are not eligible to be Corporate members and who have an active interest or participate in the electrical industry.
- 3. Electrical tradespersons, Registered Electrical Contractors, Electrical Supervisors or Electrical Trade Teachers who have an interest in keeping up to date with the latest developments in the Industry.

# Senior Membership eligibility (Clause 9.2b (iv) IEI Constitution June 2012)

- a) Senior Card Holder (Government issued), or,
- b) Are over 65 years of age, and,
- c) May only nominate for a Director's position if a Corporate membership had been held prior to applying for "Senior Member" membership status.

Membership Fee is set at 50% of the annual membership fee and nomination fee remains the same.
